Officer Scheme of Delegation

For the avoidance of doubt, I would like to clarify the intention of paragraph 5 of this report. The change to the Constitution which this paragraph notes does not reflect the introduction of a 'new power' or delegation. Rather it expresses the Monitoring Officer's existing duty to monitor and review the Constitution and to be aware of best practice in framing the content of the Constitution.

In this case, the suggestion is that the Constitution should include a statement that any incorrect citing of the Constitution, or statute, shall not invalidate an authorised delegation. This is suggested to reflect recent case law that an over-emphasis on the textual wording of a decision may lead, inadvertently, to the invalidity of a decision.

The suggested change provides a Constitutional expectation that, provided there exists a demonstrable legal and constitutional basis for a decision, an erroneous reference in the wording of the decision-record should not, in itself, invalidate that decision. In this way, the amendment seeks to protect the business and service delivery of the Council from being undermined by an administrative technicality.
