### JTAI (Joint Target Area Inspection) INSPECTION REPORT of the multi-agency response to child sexual abuse in the family environment in Oxfordshire.

2. **Executive Summary**

The Oxfordshire Safeguarding Children Partnership (OSCP) is the statutory multi-agency partnership responsible for ensuring that safeguarding arrangements across Oxfordshire are effective in protecting children and young people and promoting their welfare. Operating in line with Working Together to Safeguard Children 2026, the partnership brings together statutory safeguarding partners, the local authority, health, and police, alongside education and wider partners to deliver coordinated, high-quality safeguarding practice.

OSCP provides strategic leadership and oversight of safeguarding across the county, ensuring that partners work effectively together, that learning drives improvement, and that children and young people are seen, safe, and heard. Each agency retains individual accountability for its own safeguarding practice, while sharing collective accountability for the effectiveness of the multi-agency system.

A Joint Targeted Area Inspection (JTAI) undertaken in February 2026 examined the effectiveness of the multi-agency response to child sexual abuse in the family environment in Oxfordshire.

The inspection found that when children are at evident risk of being sexually abused in their families the partnership provides a strong and effective response, with timely investigations, high-quality child-centred practice, and access to specialist support.

## Key Issues

The inspection identified key areas for improvement, including:

- Earlier identification of risk where there is no disclosure
- More consistent information sharing across agencies
- Strengthening of multi-agency risk assessment and safety planning
- Greater involvement of probation in safeguarding arrangements
- Improved use of data to understand prevalence and risk

These findings align with national learning, particularly the Child Safeguarding Practice Review Panel report "*I wanted them all to notice*", which highlights the need for professionals to recognise and respond to non-verbal indicators of abuse.

The Oxfordshire Safeguarding Children's Partnership (OSCP) has developed a multi-agency action plan to address these areas, building on existing strengths in practice and governance.

The progress of the actions will be reviewed through the governance of the OSCP with accountability resting with the Lead Safeguarding Partners.

3. Local multi-agency safeguarding arrangements are the collective responsibility of chief officers in the County Council, the Integrated Care Board and Thames Valley Police as set out on Working Together to Safeguard Children 2026
4. These three senior safeguarding partners agree ways to co-ordinate their safeguarding services for children; act as a strategic leadership group in supporting and engaging others; and implement local and national learning including from serious child safeguarding incidents. The arrangement is referred to as the "Oxfordshire Safeguarding Children Partnership (OSCP)".
