IMPROVING AND EXTENDING PROVISION FOR CHILDREN AND YOUNG PEOPLE IN OXFORDSHIRE CHILL OUT BIDS FOR 2011

Report by the Director for Children, Young People & Families

Introduction

1. Oxfordshire County Council believes that YOUTH MATTERS and has set up a fund of £100,000 to support work with children and young people across the county. The fund supports the aspirations of those working with children and young people in Oxfordshire to ensure all children and young people can access positive activities in their leisure-time by 2020.
2. We know that how children and young people spend their leisure-time has an important influence and impact on their resilience and their quality of life. Engaging in constructive activities can increase children and young people's positive attitudes, improve motivation, increase aspirations, develop social and life skills, enhance interpersonal skills and help build social capital. All of which is vital for children and young people to help them avoid taking risks such as experimenting with drugs/alcohol or being involved in anti-social behaviour and crime. Participation in positive activities can also help increase the resilience of vulnerable children and young people who are trying to rebuild their lives. For children and young people with physical or learning disabilities it can be a lifeline and reduce social isolation. For groups such as young carers, positive activities provide respite and can improve their outlook and quality of life.
3. Projects must meet the broad aspirations above and be targeted at children and young people 8 – 19 years (extended to 24 years for young people with learning disabilities).
4. The Chill Out Fund will consider a wide range of bids supporting children and young people's access to positive activity. Applications for funding are invited that comply with the following criteria:
 - Aimed at children and young people 8 – 19 (up to 24 for those with learning disabilities).
 - Show evidence of the involvement of young people in the application.
 - Demonstrate increased access to positive leisure-time activity.
 - Show matched funding from a source external to the county council.
 - Demonstrate the ability to account for funding.
5. Applications will be considered on a monthly basis.

Having been selected from over 90 applicants, we now have to raise the cost of sending and equipping the unit to the Jamboree. The total cost of the event for our Unit is £92,000 which includes all equipment, flights, activities & food. In order to be selected I had to attend a selection event which involved various team challenges, that enabled the judges to decide who were the most suitable candidates, that would benefit most from such an experience, and be able to share that experience with others.</p>

Over the last 4 months we have consulted with the 4 groups involved in the 'Raising the Bar' project 20 ten year olds at St Ebbes primary school, 20 refugees, asylum seekers and immigrants at Oxford and Cherwell Valley College, 20 young people with learning disabilities at Abingdon and Witney College (Witney campus) and 20 young people with learning disabilities at Abingdon and Witney College (Abingdon campus). They brainstormed ideas and developed concepts for the 4 films. (Please see enclosed DVD and example brainstorming sheets)

What do you want to do? (please describe the project you want funding for)

Over the next 8 months we will be working with the above 4 groups to create short experimental films around the Olympic themes of Courage, Friendship, Inspiration and Respect. The core funding for this work has been confirmed by First Light – the Lottery fund that supports young film makers and digital creators. (£29,800)

As part of the project we would like to screen the completed work to wider audiences and plan to run 4 screening events. All events will be open to the general public and be free. We would like to apply to the Chill Out fund to support these events.

For each event we will recruit 5 young people to make up the Event Management team. They will have 2 days of training at OFVM film Oxford in all areas of event management including: planning, publicity, design, marketing (including e marketing + social network sites) technical set ups and organization and delivery on the day.

Event 1. An open air 'film in the parks' screening in Hinksey park, Oxford. 2 films will be shown before a major family feature. July 23rd 2011 (estimated audience 300 people)

Event 2. An open air 'film in the parks' screening in Bury Knowle park, Oxford. 2 films will be shown before a major family feature. July 30th 2011. (estimated audience 300 people)

Event 3. A Phoenix Picture House premiere screening of 4 films to celebrate the completion of all films. November 2011. (estimated audience 120 people)

Event 4. White Nights Christmas screening. An open air screening in Gloucester Green Oxford showing all 4 films on a continuous loop. November 2011 (estimated audience 500 people plus)

Why is your project important? (and why do you want to do it?)

The events are important as they will offer a public celebration of the work that 80 young people have been involved in. They will show a wider public how young people can be involved in positive activities and create thought provoking film work. They will reach a total audience of over 1000 people and offer new screening activities for young people in and around Oxford.

Each screening event will be organized and run by an event management team of 4 young people with the support of a professional event manager from Film Oxford. They will learn design, marketing, technical and general event management skills as they plan, develop and run each screening.

How will your project help or benefit children and young people in the community?

Young people involved in the production of the films will feel a sense of pride and achievement as their work is seen by wider audiences.

The event management teams will learn new specific and transferrable skills. (eg. reliability, team work, technical skills, design, marketing and event management)

The young audience will view work created by their peers and feel inspired to make films themselves.

The work produced by the groups with learning disabilities and refugees, asylum seekers and immigrants will help confront prejudices and preconceived ideas of these groups.

Children and Young people will enjoy watching the films and be part of a larger celebration of the work bringing communities together.

The events will be free and enable young people from low income families be part of memorable screening events at night.

The young people have been aware of the threat of closure of the Youth Club for the past six months. As a result they have been involved in fund raising activities and in searching for other sources of funding.

12 members attended the Goring Parish Council meeting in November and George spoke at the part of the meeting open to the public - see extract from minutes attached

G&DYC has a Youth Forum and regularly discusses its activities and issues that are of concern with all members.

The recently submitted report by Jennie Denton, Youth Leader outlining use of last years Chill-Out grant is attached – this evidences the engagement with young people through-out the year.

To keep this successful Youth Club going!

G&DYC meets every Wednesday throughout term time and during some of the holidays as well as running a summer holiday project.

We regularly have up to 50 members attending of an evening and over 20 attended the 3 weeks summer holiday project.

Why is your project important? (and why do you want to do it?)

G&DYC is a really successful rural youth club that meets the needs of a substantial number of young people from the village and surrounding area.

The Club attracts a wide range of young people and currently 25% of its membership has special educational needs. As a result we need additional support and skills of staff and volunteers to make sure the club is able to attend to the needs of the groups and specific individuals.

Support of individual young people outside Club sessions has included contact with parents, local schools, extended services and in some case Child protection matters.

Whilst we have a group of regular and loyal volunteers we do need the support of a qualified leader and support assistant to manage the organisation and run the Club.

How will your project help or benefit children and young people in the community?

Activities of young people in rural locations are limited in South Oxfordshire.

Our Club provides a social meeting point as well as specific activities (e.g. recent dance training; under 16 football, & Boxing,) for a wide range of young people.

We integrate young people from a range of backgrounds and social and physical abilities including those with autism and other serious Learning Difficulties and Disabilities.

The Summer holiday project offers a series of activities and events over a three week period that otherwise, for many would hold little excitement or offer of new experiences e.g. sailing, visiting to London museums as well as local activities.

The CDI's Youth Project is important because it can fill the gap in provision, which is widening ever more as funding cuts in the already constrained statutory sector bite into the little provision that does exist. Because the CDI does not have to target specific groups it can reach out to a wider youth public, and bring a range of young people within its project to socialise, learn new skills and work together. This is particularly good for those young people who often say to us "only the bad kids get everything!", It is a key principle of our work to offer activities for **all** young people in the Leys, and not just the 'targeted groups'.

We would like to also like to make it clear the CDI project were successful in a achieving a Lottery Bid **YP2** in August 2009 – **YP2** is a youth participatory project delivering a range of educational and diversionary activities (funded until 2013). This grant must be used to achieve specific targets and outcomes and **does not** cover the CDI's 'general, inclusive' work that seeks to provide holiday activities and opportunities open to all young people in the Leys.

How will your project help or benefit children and young people in the community?

The Easter Project will:

- Bring young people together
