IMPROVING AND EXTENDING PROVISION FOR CHILDREN AND YOUNG PEOPLE IN OXFORDSHIRE CHILL OUT BIDS FOR 2012/2013

Report by Director for Children's Services

Introduction

1. Oxfordshire County Council believes that YOUTH MATTERS and has set up a fund of £100,000 to support work with children and young people across the County. The fund supports the aspirations of those working with children and young people in Oxfordshire to ensure all children and young people can access positive activities in their leisure-time by 2020.
2. We know that how children and young people spend their leisure-time has an important influence and impact on their resilience and their quality of life. Engaging in constructive activities can increase children and young people's positive attitudes, improve motivation, increase aspirations, develop social and life skills, enhance interpersonal skills and help build social capital. All of which is vital for children and young people to help them avoid taking risks such as experimenting with drugs/alcohol or being involved in anti-social behaviour and crime. Participation in positive activities can also help increase the resilience of vulnerable children and young people who are trying to rebuild their lives. For children and young people with physical or learning disabilities it can be a lifeline and reduce social isolation. For groups such as young carers, positive activities provide respite and can improve their outlook and quality of life.
3. Projects must meet the broad aspirations above and be targeted at children and young people 8 – 19 years (extended to 24 years for young people with learning disabilities).
4. The Chill Out Fund will consider a wide range of bids supporting children and young people's access to positive activity. Applications for funding are invited that comply with the following criteria:
 - Aimed at children and young people 8 – 19 (up to 24 for those with learning disabilities).
 - Show evidence of the involvement of young people in the application.
 - Demonstrate increased access to positive leisure-time activity.
 - Show matched funding from a source external to the county council.
 - Demonstrate the ability to account for funding.
5. Applications will be considered on a monthly basis.

The culmination of this was that the young people produced a rap video, which they wrote themselves. The Banbury Foyer is now undergoing refurbishment and residents would like to work with Community Albums to produce a video diary of the refurbishment and their thoughts about it, which they will show at an 'open day' once the refurbishment is completed.</p>

<p>What do you want to do? (please describe the project you want funding for)</p> <p>To produce a video diary showing progress of a refurbishment of the foyer and thoughts of the residents e.g. how this refurb will affect them/improve their lives. With the support of Community Albums residents will film the progress, interview each other and staff, plan what they need to film/produce, select music and be involved in post production and editing. They will also film themselves making the diary in a documentary form. The young people will then organise an open day to show this to the local community.</p>

Why is your project important? (and why do you want to do it?)

The project is important to the young people on many levels. It will give them access to a leisure-time positive activity and improve their employability, confidence and self-esteem. This project will also bring the Fazel community together and allow them to express their views and feelings. The project outcome will also raise the profile of the Fazel within the local community and hopefully change any negative perceptions.

How will your project help or benefit children and young people in the community?

This project will provide many benefits to the young people offering a positive leisure-time activity, unlocking skills and talents and improving employability and will help towards achieving economic wellbeing. By positively contributing to this project the young people's confidence and self-esteem will grow, resulting in less anti-social behaviour. <p>What do you want to do? (please describe the project you want funding for)</p> <p>We will be running our fifth Summer Project throughout July and August 2012, and it has previously been incredibly successful. In the past we have had 400 young people engaging in the project over one summer, and we hope to continue this success this year. Please refer to the project costs section for details of the activities we plan to conduct, all of which have been selected by young people. We run the Summer Project to engage young people in activities which will stimulate them physically, mentally and educationally. The majority of young people working with Base 33 are from chaotic backgrounds due to factors such as substance misuse, family breakdown or sexual health issues, and we work with them tackling issues such as antisocial behaviour or being classed as NEET. Young People engaging in the Summer Project may have been referred to us by Henry Box</p>

School, Thames Valley Police, West Oxfordshire District Council Safer Partnership Team, Youth Offending Service, Young Addaction, Witney Job Centre, Connexions and Base 33 Detached Team. All of these young people will benefit from gaining accreditations, self-confidence, support and will meet new people during the summer project.

Why is your project important? (and why do you want to do it?)

The work that Base 33 undertakes has been reported by the West Oxfordshire Safer Partnership Team as decreasing antisocial behaviour by 20%, and a large part of this is achieved via the Summer Project. The Summer Project allows young people to spend time with us as workers, improving relationships and increasing engagement with us as an organisation, and this increased trust and interaction allows us to increasingly support their needs. All of the activities in the Summer Project are designed to challenge young people by giving them educational, challenging and fun opportunities.

The project is also vital in allowing young people to build confidence, increase their knowledge and express themselves via working with both their peers and Base 33, which is important to their development and engagement with society.

How will your project help or benefit children and young people in the community?

As aforementioned, the Summer Project has a vital impact on anti-social behaviour in Witney and the surrounding areas; young people are removed from situations where they may enter into ASB and instead places them in an environment where they can undertake challenging, educational and fun experiences. Those who participate in the Summer Project are awarded with a certificate, which subsequently helps young people as they can include it on their CV as an achievement, therefore supporting them with job applications and opportunities.

As well as providing young people with educational and challenging opportunities, it also allows them to have fun, which is vital to them. As mentioned, many of the young people come from a chaotic background, and the Summer Project is an excellent opportunity for them to engage in activities which would not ordinarily be available to them.

Children are asked for feedback at the end of every playscheme as to what they have enjoyed most and what activities they would like to have in next year's playscheme and these views (where realistic) are taken into account when planning the next year's programme (see attached list). Parents are also asked annually for feedback in questionnaires and are generally extremely appreciative of the quality of staff, activities and good value. In 2011 of 12 parents asked, 10 gave 10/10 for overall quality. The playscheme has become an institutional part of life on the Estate and many children ask community workers throughout the year when it is going to start again. Many children attend for 6 or 7 years running, from the age of 5 to 11 years.

As the children only gather annually for this event it has not been possible to collect a lot of data from them at this moment in time.

Why is your project important? (and why do you want to do it?) The Playscheme provides affordable high quality play activities for around 50 children living on low incomes on the Cutteslowe Estate, thus supporting struggling families to cope in the long summer holidays, reducing social inequality in North Oxford and building community cohesion. Unlike many of their more affluent neighbours many children from Cutteslowe have little to do in the long school holidays.

It is anticipated that around 50% of the children will be from families on benefits (as in 2011) and a high proportion will have SEN. Many of the children are from single parent households where there are often additional multiple problems such as debt, substance misuse and poor educational aspiration and achievement. Many parents give only the basic minimum of care to their offspring and they are left to roam the streets for most of the summer holidays.

The Playscheme provides varied and stimulating activities which extend the experiences and life skills of 50 disadvantaged children per week. The scheme also builds positive nurturing relationships between workers and children which promote healthy child development and reduce the long-term risks of anti-social behaviour. Well-being is enhanced through healthy eating, outdoor activities, swimming and visits to the community allotment. The children also develop a relationship with the permanent community workers and start to feel at home in the community centre which means they and their families access other activities ongoingly and this reduces the risk of offending behaviour longterm.

Feedback from children is gathered at the end of each week and parents are given questionnaires after each playscheme and are consistently positive about the good value, quality of activities and positive educational opportunities it provides.

How will your project help or benefit children and young people in the community?

The Playscheme will provide support for local families during the summer holidays. 50 children per week will be constructively engaged in high quality provision which will not only keep them off the streets, but will extend their skills and experiences. There is an emphasis on healthy living, cooking, well-being, team-work and confidence building. Two workshops with Pegasus Theatre give children access to working with professional artists and dancers.

Creative activities, sport and team games and free play will enable the participants to engage in new ways, develop confidence and self-expression, build new relationships with positive adult role models and broaden their horizons. Trips to Hill End and Farmer Gow's Activity Farm give new experiences as do engagement with the community allotment.

Anti-social behaviour is expected to be reduced on the estate through purposeful activity and team games and a visit from the Police Community Support Officer will help to build trust in the Police from a young age. The first day will be a training day to build the staff team, and address health and safety and child protection issues.

The Playscheme also enables Community Workers to build ongoing relationships with children on the estate from a young age, which encourages their engagement and reduces the risks of them developing offending behaviour. It also means that children are more likely to access other regular after-school clubs and youth work provision run by the Community Association and St Andrew's Youth Workers as they grow older.

Working with a group of young people from The Foyer supported accommodation in Abingdon, the charity identified a need for more ~~positive~~ ^{readily} available recreational activities. The Foyer group of young people came up with the idea of running weekly football sessions. To help with this application, the group got together to discuss the best place to hold the sessions, that would be easily accessible to a range of young people. The group then delegated tasks to different members. One person had to find out how much it would cost to hire a pitch for the year. One group member compiled a list of all the people who attend the sessions, as well as their ages & where they lived, so that we could provide accurate details about the beneficiaries. Another person took photos of the team, to show evidence of the team in action.

What do you want to do? (please describe the project you want funding for)
Run weekly 5-a-side football training for young people at Abingdon Leisure Centre. The sessions will take place on Wednesdays at 4.30pm. The sessions will be run by a local Youth Worker, who will act as both coach and mentor to the young people.
In September, the team will organise a Community Football Tournament for everyone in the local neighbourhood. Local businesses, charities, schools, residents, and young people will be invited to form teams and compete for the trophy.

Why is your project important? (and why do you want to do it?) It reduces anti-social behaviour and youth underachievement in the local area. It will increase participation in sport & encourage healthy lifestyles. The young people play football with and against other youth teams from the local area, aiding community cohesion & irradiating youth rivalry & gang culture. The Community Football Tournament will get the young people more engaged in their local community. The event will bring local people of different ages & backgrounds together through fun & healthy competitive sport. Local businesses, charities, residents, & young people will come together to take part, aiding positive community relationships & networking.

How will your project help or benefit children and young people in the community? The sessions will not only benefit the physical wellbeing of the young people, it will improve their team skills, confidence and motivation to succeed. Why is your project important? (and why do you want to do it?)

Unfortunately, there is no youth club in Yarnton. Whilst there are a number of activities available during summer evenings there is nothing during the winter months. The Parish Council wish to help provide safe and secure recreational facilities for young people and see the youth bus as an opportunity to achieve this objective.

Experience has shown in previous years that the occupation of young people in consistent purposeful activity significantly reduces incidents of misbehaviour within the age group. Previous visits of the bus to Yarnton have been most successful, well supported by the young people with absolutely no misbehaviour by them and with no complaints from any residents.

How will your project help or benefit children and young people in the community?

The recent 10% increase in the village population has inevitably increased the number of children who need the opportunity to engage with their peers outside of school. Equipment on the bus gives the young people the chance to use a variety of communication equipment that might not be available to them outside of school. This will enable them the opportunity to be creative in a number of different ways within safe and secure conditions.
