

Detail of proposal

Context / Background	The Biodiversity Action Framework and Action Plan have been produced to fulfil the Council's obligations to conserve and enhance biodiversity under the strengthed biodiversity duty introduced by the Environment Act 2021.
Proposal	The Biodiversity Action Framework and Action plan introduces a wide range of policies and associated actions to support the Council in conserving and enhancing biodiversity. This fulfils a legal requirement under the Environment Act 2021, but also supports the Oxfordshire Environmental Principles and delivery of a range of the Council's Corporate Priorities. The policies and actions have been developed through internal consultation with Council staff.
Evidence / Intelligence	The Biodiversity Action Framework and Action Plan were developed through consultation with Council staff, including the Climate Action Team. Feedback from the Climate Action Team has been taken on board and integrated into the Framework, most of this feedback focussed around ensuring the Biodiversity Action Framework aligns with the Climate Action Framework, Carbon Management Plan, Climate Adaptation Route Map and Circular Economy Strategy as well as useful feedback on lessons learnt from development of these documents.
Alternatives considered / rejected	Doing nothing is not an option, since the Framework and Action Plan have been developed to fulfil a legal obligation. Intial consideration of actions was developed through consultation across Council service areas and refined through consultation and direct discussion with relevant teams.
