A final bid was submitted to the Fund under these arrangements in June 2012, before administration of the Fund changed to individual Councillor Community Budgets.</p> <p>The Cabinet Member for Children & the Voluntary Sector is asked to determine this bid in line with previous arrangements.</p> <p>The report summarises the final bid received for Adderbury Alive - Expanding Community Facilities including service and councillors' comments and asks the Cabinet Member with responsibility for the Big Society Fund to consider the bid and recommends whether to award funding.</p> <p><i>The Cabinet Member for Children & the Voluntary Sector is RECOMMENDED to approve the bid for Adderbury Alive - Expanding Community Facilities which meets the assessment criteria.</i></p>
