<b>3. Petitions and Public Address</b>	Robin Peake, Communications & Development Manager, spoke in support of the Chill Out Fund application for Innovista.	
<p><b>4. Local Residential Detoxification Project (Howard House)</b></p> <p>The Council has a statutory obligation to “take such steps as it considers appropriate for improving the health of the people in its area” (s2B National Health Service Act 2006 (“NHS Act 2006”) as amended by s12 Health and Social Care Act 2012). This includes “providing services or facilities for the prevention, diagnosis or treatment of illness” (s 2B (3) (c) NHS Act 2006).</p> <p>Public Health has a ring fenced budget, and within this an allocation has been made for substance misuse services for adults. This information is reported to the Cabinet.</p> <p>The contracts with the current provider expires on 30/9/2014, so a decision is required in order to proceed with procurement arrangements.</p> <p>Costs of commissioning these services is greater than £500,000 and commitment to incur this expenditure has not previously been made by the Council due to existing contracts having been transferred in on 1 April 2013.
