COUNCILLOR CHARLIE HICKS</p> <p>As "putting action to address the Climate Emergency at the heart of our work" is our top stated priority as the Oxfordshire Fair Deal Alliance, please could Cabinet provide greater transparency on how much funding is being put towards this priority in the upcoming budget, by summing and publishing the total spend in both draft revenue and capital budgets on climate mitigation (e.g. funding towards reducing number of car journeys, retrofitting buildings) and climate adaptation (e.g. flood defenses) spend?</p>	<p>COUNCILLOR CALUM MILLER, CABINET MEMBER FOR FINANCE</p> <p>As you say, we are committed to putting these actions at the heart of our work. This requires a step-change in institutional capacity as well as new funding and investments in specific programmes. The Cabinet has proposed a significant portion of its proposed new revenue investment to enhance the ability to mainstream actions and monitor interventions to deliver on our climate action priority. The following measures are included as additional investment in the MTFs and Capital Programme which total £6.4m in 2022/23 alone – see table below.</p>

COUNCILLOR CHARLIE HICKS</p> <p>Please could Cabinet outline what actions will be taken to address Recommendation 5 in the Budget Scrutiny Observations and Recommendations Report by Performance Scrutiny Committee? For example, what plans are there currently to allocate funding from the not-yet specified budget reserves towards the Climate Emergency in order to operationalise the PaZCO report, mainstream Climate policymaking across all departments and ensure the council has the capacity to calculate scope 1, 2, and 3 emissions from all existing and future major capital projects?</p>	<p>COUNCILLOR CALUM MILLER, CABINET MEMBER FOR FINANCE</p> <p>The Cabinet will publish its response to the Budget Scrutiny Observations and Recommendations Report by Performance and Corporate Services Overview and Scrutiny Committee ahead of the Cabinet meeting on 18th January.</p>
