

HIGHWAYS ACT 1980

THE OXFORDSHIRE COUNTY COUNCIL (HIGHWAYS INFRASTRUCTURE – A40 HIF2 SMART CORRIDOR (HILL FARM TO DUKES CUT)) (SIDE ROADS) ORDER 2022

Oxfordshire County Council (“the Council”) make this Order in exercise of their powers under Sections 14 and 125 of the Highways Act 1980 and all other powers enabling them in that behalf: –

1. (1) The Council is authorised in relation to the Classified Roads in the Parishes of South Leigh, Eynsham, and Cassington, in the District of West Oxfordshire, and in the Parishes of Yarnton, and Gosford and Water Eaton, in the District of Cherwell, and in the City of Oxfordshire, all in the County of Oxfordshire to: -
 - (a) improve the lengths of highway named in the Schedules and shown on the corresponding Site Plan by cross hatching;
 - (b) stop up each length of highway described in the Schedules and shown on the corresponding Site Plan by zebra hatching;
 - (c) construct a new highway along each route whose centre line is shown on a Site Plan by an unbroken black line surrounded by stipple;
 - (d) stop up each private means of access to premises described in the Schedules and shown on the corresponding Site Plan by a solid black band; and
 - (e) provide new means of access to premises along each route or at each location shown on a Site Plan by thin diagonal hatching.
- (2) Where a new highway is to be constructed wholly or partly along the same route as a new access or part of one, that new highway shall be created subject to the private rights over that new access.
- (3) Each new highway is given a reference number and letter on a Site Plan, which is also placed in the respective Schedule, and will be a road unless the word “Footpath”, “Bridleway” or “Cycle Track (with a right of way on foot)” appears beneath its reference letter in the Schedule, in which case it will be a Footpath, Bridleway or Cycle Track (with a right of way on foot) as the case may be. Each new access is given a reference number followed by a lower case letter on a Site Plan, which is also placed in the respective Schedule.
- (4) Where a new highway is to be constructed or a new access is to be provided in connection with the stopping up of a length of highway or private means of access described in a Schedule, its reference letter or number (as the case may be) is placed in the said Schedule opposite the description of that length.
- (5) Each Site Plan shows the works indicated in the respective Schedule and has the same number as that Schedule and the route of the Classified Roads is shown in relation to those works.

2. Where immediately before a length of highway is stopped up in pursuance of this Order there is under, in, on, over, along or across that highway any apparatus of statutory undertakers or any telecommunications code system operator then, subject to Section 21 of the Highways Act 1980, those undertakers, or that operator, as the case may be, shall have the same rights as respects that apparatus as they had immediately before the stopping up took place.

3. In this Order –

(1) Distances are measured along the route of the relevant highway or private means of access to premises, as the case may be;

(2) A reference to a Schedule or Site Plan number is a reference to the Schedule, or to the Site Plan, so numbered;

(3)

(a) “the Classified Roads” means –

(i) the A40 which the Council propose to improve from a point approximately 174 metres west of the Hill Farm Overbridge, which carries Bridleway 353/19/20 (South Leigh) over the A40, eastwards for a distance of approximately 689 metres, to a point approximately 64 metres west of the junction of the A40 with the Private Access Track to Whitehouse Farm and Nos 1 and 2 Whitehouse Farm Cottages;

(ii) the highway which the Council propose to construct, as the proposed A40, from a point on the existing A40 approximately 64 metres west of the junction of the A40 with the Private Access Track to Whitehouse Farm and Nos 1 and 2 Whitehouse Farm Cottages, eastwards for a distance of approximately 415 metres to a point approximately 146 metres east of the junction of the A40 with the westerly Private Access Track to Salutation Farmhouse and Salutation Barn; and

(iii) the A40 which the Council proposed to improve from a point approximately 146 metres east of its junction with the westerly Private Access Track to Salutation Farmhouse and Salutation Barn, generally eastwards for a distance of approximately 9.758 kilometres to a point approximately 134 metres east of the centre line of the A34 Western Bypass bridge over the A40, and which improvement of the A40 may, at the time of its implementation, be implemented by way of a continuous dual carriageway eastwards, at a point just east of Eynsham Motocross, or with a Roundabout Junction included at that location,

and which are highway and a proposed highway which is a classified road in accordance with section 12 of the Highways Act 1980;

- (b) “the Council” means Oxfordshire County Council;
- (c) “improvement” in relation to a highway includes raising, lowering or otherwise altering that highway, and “improved” shall be construed accordingly;
- (d) “new access” means a means of access to premises authorised by this Order to be provided;
- (e) “new highway” means a highway authorised by this Order to be constructed and “new highways” shall be construed accordingly;
- (f) “Schedule” means a Schedule to this Order, and “Schedules” shall be construed accordingly;
- (g) “Site Plan” means one of the Site Plans numbered 1 to 9 marked “The Oxfordshire County Council (Highways Infrastructure – A40 HIF2 Smart Corridor (Hill Farm to Dukes Cut)) (Side Roads) Order 2022”, sealed with the Common Seal of the Council and deposited at the offices of the Council at County Hall, Oxford OX1 1DJ;

a duplicate copy has been deposited at the offices of the Secretary of State for Transport.

THE SCHEDULES (1 TO 9)

Explanatory Notes:

- (a) Where a reference number appears in brackets within a description of, or as a reference point in relation to, a Highway to be stopped, in a Schedule, or as a reference point within a description of a Private Means of Access to be stopped up, that reference number is a local reference number of the Local Highway Authority of the Unclassified Road to which the description or reference point description relates. That local reference number also appears in brackets against the Unclassified Road to which it relates on the corresponding Site Plan.
- (b) New Bridleways 1/A, 1/C, and 1/D, on Site Plan 1; 2/A on Site Plan 2; and 3/A on Site Plan 3, are parts of what will be one new Bridleway Route, from its junction, in the west, with Bridleway 353/19/10 (South Leigh) and Bridleway 353/19/20 (South Leigh), and with the Unclassified Road (43655199), which leads westwards off the C35469 at Barnard Gate North, in the east, which new Bridleway route will be situated on the northern side of the A40 Principal Road.
- (c) Along the New Bridleway(s) Route referred to in (b) above, will be provide a new continuous co-existent Private Means of Access Route, 1/a, 1/c, and 1/d, on Site Plan 1; 2/a, 2/b, 2/c, 2/d, and 2/e, on Site Plan 2; and 3/a, 3/b, 3/c, and 3/d, on Site Plan 3, and over which private vehicular rights will be provided, to the premises which lie to the north side of the Private Means of Access Route corridor.
- (d) New Bridleways 1/B on Site Plan 1; 2/B on Site Plan 2; and 3/B on Site Plan 3, are parts of what will be one new Bridleway Route, from its junction, in the west, with Bridleway 353/19/30 (South Leigh), and with the new highway 3/D, lying to the east of the Unclassified Road (43603545), which leads southwards off the A40 Principal Road.
- (e) Along the New Bridleway(s) Route referred to in (d) above, will be provided a new continuous co-existent Private Mean of Access Route, 1/b on Site Plan 1; 2/f on Site Plan 2; and 3/e (part), 3/f (part), and 3h (part) on Site Plan 3, and over which private vehicular rights will be provided, to the premises which lie to the south side of the A40 Principal Road and to the west of the Unclassified Road (43603545).
- (f) In relation to the new Private Means of Access Routes, referred to in (c) and (e) above, and any other new Private Means of Access Route, the reference number and letter of each of the lengths which will make up the entire new Private Means of Access Route for any particular premises, appears opposite the description of the Private Means of Access which is to be stopped up to that premises in the relevant Schedule.
