About the County Council

The Oxfordshire County Council is made up of 74 councillors who are democratically elected every four years. The Council provides a range of services to Oxfordshire's 630,000 residents. These include:

schools	social & health care	libraries and museums
the fire service	roads	trading standards
land use	transport planning	waste management

Each year the Council manages £0.9 billion of public money in providing these services. Most decisions are taken by a Cabinet of 9 Councillors, which makes decisions about service priorities and spending. Some decisions will now be delegated to individual members of the Cabinet.

About Scrutiny

Scrutiny is about:

- Providing a challenge to the Cabinet
- Examining how well the Cabinet and the Authority are performing
- Influencing the Cabinet on decisions that affect local people
- Helping the Cabinet to develop Council policies
- Representing the community in Council decision making
- Promoting joined up working across the authority's work and with partners

Scrutiny is NOT about:

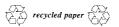
- Making day to day service decisions
- Investigating individual complaints.

What does this Committee do?

The Committee meets up to 6 times a year or more. It develops a work programme, which lists the issues it plans to investigate. These investigations can include whole committee investigations undertaken during the meeting, or reviews by a panel of members doing research and talking to lots of people outside of the meeting. Once an investigation is completed the Committee provides its advice to the Cabinet, the full Council or other scrutiny committees. Meetings are open to the public and all reports are available to the public unless exempt or confidential, when the items would be considered in closed session

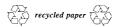

Declarations of Interest

This note briefly summarises the position on interests which you must declare at the meeting. Please refer to the Members' Code of Conduct in Part 9.1 of the Constitution for a fuller description.

The duty to declare ...

You must always declare any "personal interest" in a matter under consideration, ie where the matter affects (either positively or negatively):

- (i) any of the financial and other interests which you are required to notify for inclusion in the statutory Register of Members' Interests; or
- (ii) your own well-being or financial position or that of any member of your family or any person with whom you have a close association more than it would affect other people in the County.

Whose interests are included ...

"Member of your family" in (ii) above includes spouses and partners and other relatives' spouses and partners, and extends to the employment and investment interests of relatives and friends and their involvement in other bodies of various descriptions. For a full list of what "relative" covers, please see the Code of Conduct.

When and what to declare ...

The best time to make any declaration is under the agenda item "Declarations of Interest". Under the Code you must declare not later than at the start of the item concerned or (if different) as soon as the interest "becomes apparent".

In making a declaration you must state the nature of the interest.

Taking part if you have an interest ...

Having made a declaration you may still take part in the debate and vote on the matter unless your personal interest is also a "prejudicial" interest.

"Prejudicial" interests ...

A prejudicial interest is one which a member of the public knowing the relevant facts would think so significant as to be likely to affect your judgment of the public interest.

What to do if your interest is prejudicial ...

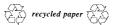
If you have a prejudicial interest in any matter under consideration, you may remain in the room but only for the purpose of making representations, answering questions or giving evidence relating to the matter under consideration, provided that the public are also allowed to attend the meeting for the same purpose, whether under a statutory right or otherwise.

Exceptions ...

There are a few circumstances where you may regard yourself as not having a prejudicial interest or may participate even though you may have one. These, together with other rules about participation in the case of a prejudicial interest, are set out in paragraphs 10 - 12 of the Code.

Seeking Advice ...

It is your responsibility to decide whether any of these provisions apply to you in particular circumstances, but you may wish to seek the advice of the Monitoring Officer before the meeting.

COMMUNITY TRANSPORT STRATEGY

Update note for Growth and Infrastructure Scrutiny Committee 14th July 2011

Project Sponsor:Tracey Dow (Highways & Transport)Project Manager:Jayme Radford (Highways & Transport)

Purpose of this briefing note:

1. On Wednesday 25th May, a presentation on Community Transport was given to the Committee to introduce the Community Transport project and provide the Committee with an overview of Community Transport service provision in Oxfordshire.

2. This briefing note aims to update the Committee on the progress made since the last meeting in developing a Community Transport Strategy for Oxfordshire.

Progress to date:

3. Since the 25th May presentation, a Project Team has been set up, incorporating staff from Environment & Economy, Social & Community Services, and Children, Education & Families. The project team is also supported by a member of the Policy Unit. An initial Project Team meeting was held on 23rd June, 2011.

4. A Scrutiny Members' Working Group has been formed to contribute to the development of the strategy. An initial meeting was held on 30th June, 2011.

5. Research is being undertaken to understand best practice across the country, and initial reviews of existing Community Transport service provision across Oxfordshire have been conducted. This information has been detailed and presented to both groups in a draft Project Implementation Plan (PID). The development of the PID is being guided by Scrutiny members and the Project Team.

Next steps:

6. The Project Manager is arranging for providers and others to meet with the Scrutiny Members' Working Group and members of the Project Team. There is a general consensus that this will be beneficial for the development of the Oxfordshire Strategy. These organisations are likely to include the *Community Transport Association, HCT Group* and *Third Sector Services*.

7. Members of the Project Team are currently in discussions with the five district councils to gauge an understanding of funding allocations for the 2012/2013 financial year.

8. The Project Manager will aim to finalise a PID and Project Plan for development of the Strategy by August, 2011. This will require sign-off from the Environment & Economy Leadership Team.

9. It is envisaged that an overarching Community Transport Strategy will be in place by January / February 2012 (*date to be confirmed as the Project Plan develops*). The strategy will set out a clear aspiration for Community Transport across Oxfordshire, and include an Action Plan for taking the Strategy forward.
