# CABINET MEMBER FOR HIGHWAY MANAGEMENT 26 JANUARY 2023

# BANBURY: CENTRAL (WEST) AREA - PROPOSED PARKING MEASURES INCLUDING RESIDENTS PERMIT PARKING SCHEME

Report by Corporate Director, Environment and Place

#### Recommendation

 The Cabinet Member for Highway Management is RECOMMENDED to approve the proposals as advertised for parking measures at Beargarden Road, Crouch Street, Monument Street, New Road, West Bar Street and Westbeech Court.

#### **Executive summary**

- 2. Following the introduction of Civil Parking Enforcement across Cherwell, South Oxfordshire and The Vale of the White Horse districts in November 2021, many requests have been received to review existing parking restrictions. One of these requests was received from Councillor Reeves, member for Banbury Calthorpe division, to cover residential streets to the west of Banbury Town Centre. Councillor Reeves has funded the necessary consultation and advertisement costs to design and consult upon these proposals.
- 3. This report presents the consultation responses to the advertised Traffic Regulation Order (TRO) for a proposed scheme .

#### Introduction

4. Civil Parking Enforcement (CPE) was introduced across Cherwell, South Oxfordshire and The Vale of the White Horse districts on 1<sup>st</sup> November 2021. There was an expectation that a review of existing parking restrictions would be needed, and publicity in advance of CPE starting made reference to the process for reviewing restrictions and that the County Council's Parking Team would suspend enforcement of restrictions where a commitment to undertake a particular review had been agreed. Subsequently, enforcement of parking restrictions was suspended in a number of streets in Banbury, including those streets covered by the proposals in this report.

- 5. At the full meeting of the County Council on Tuesday, 23 March 2021, a petition was received from a resident of Crouch Street, Banbury (Mr Ruff) requesting:
  - "that Oxfordshire County Council give urgent and independent consideration to the following schemes to improve residents' parking, reduce traffic speeds, and make roads safer for residents, pedestrians, and cyclists. For the avoidance of doubt, there should be proper public consultation with residents on the design and timing of all schemes and Council officers should proceed with them as quickly as possible: Residents' parking schemes:
  - 1. Residents' parking schemes introduced urgently for the following roads (in alphabetical order) where properties do not already benefit from off-road parking: Beargarden Road, Berrymoor Road, Broughton Road, Crouch Street, Gilkes Yard, Hornbeam Close, Westbeech Court and West Bar Street......
  - 7. Consideration of relocating any new residents' parking spaces on Beargarden Road to the opposite side to improve visibility for pedestrians and motorists"

The petition also requested other road safety, traffic calming and active travel measures which are not covered by this project. (Full council minute no 9/12 refers).

- 6. The petition was supported by Councillor Reeves, member for Banbury Calthorpe division, and he offered to pay for the necessary TRO consultation and advertisement costs, from his 2022/23 priority funds, to design and consult upon these proposals.
- 7. The proposals are as illustrated in **Annex 1** and include 2 roads where there are existing 'time-limited' parking spaces in Crouch Street and West Bar Street. Elsewhere, the proposals include roads where parking is either unrestricted or subject to single or double yellow lines. Currently, there are no resident permit parking schemes in Banbury. The area covered by the proposals is attractive to 'non-residents' as it offers free on-street parking compared to some nearby off-street car parks which charge for parking. Hence these residential streets suffer pressure upon the limited number of spaces available.
- 8. The proposals generally do not seek to change the layout of parking spaces, except for 4 particular changes of significance:

#### i. Beargarden Road

As suggested by the petition received in March 2021, it is proposed to relocate available parking from the south-west to the north-east side of the road. In terms of numbers of parking spaces, not including across private driveways, this would increase availability from 10 spaces to 21. This involves removing existing double yellow lines on the north-east side, where it is deemed safe to do so, and introducing new ones on the south-west side where the unrestricted parking spaces used to be. There is a slight bend in Beargarden Road on the north-east side, and the road is on a hill, but it is considered that the increase in parking outweighs these factors. All the residential

properties on the south-west side currently have off-street parking, whereas most of those on the north-east side do not.

#### ii. Monument Street

The Banbury Cross Health Centre has contacted the County Council seeking assistance with indiscriminate parking near its rear entrance. This has prevented access to its own parking area for deliveries etc. To resolve this, it is proposed to restrict the whole of the Health Centre side of the road by means of a no loading or waiting restriction (at any time), and to provide 3 Disabled Persons' Parking places and a Goods Vehicle loading bay on the opposite side, in order to rationalise the parking that takes place.

#### iii. West Bar Street

In order to maximise the number of parking spaces available, it is proposed that an additional 6 spaces can be provided by removing a section of double yellow lines opposite Westbeech Court.

#### iv. Westbeech Court

In order to maximise the number of parking spaces available, it is proposed that an additional 3 spaces can be provided by removing a section of single yellow line outside Beechfield House.

9. Apart for the loading bay and the Disabled Persons' Parking places in Monument Street, and the existing Disabled Persons' Parking place outside West Bar surgery, all remaining parking spaces are proposed to operate as Permit Holders Only, operating on Mondays to Saturdays from 8am to 6pm. For residents, permits would cost £66 per permit per annum. Residents aged 70 or over would be able to apply for visitors permits, free of charge. For other residents the first block of 25 visitors permits will be free and the second block would be £25. Contractors may apply for a permit to use a parking place at a charge of £25 for any period not exceeding a week.

### **Sustainability Implications**

10. The proposals would help facilitate the safe movement of traffic and alleviate parking stress in the area, and also help encourage the use of sustainable transport modes and help support the delivery of wider transport initiatives.

### Financial and Staff Implications (including Revenue)

11. Funding for the proposals, including consultation fees and implementation costs has been provided by Councillor Reeves from his 2022/23 priority funds.

Ongoing management and enforcement costs would be met from the on-street parking account.

#### **Equalities and Inclusion Implications**

12. No equalities or inclusion implications have been identified in respect of the proposals.

#### **Formal Consultation**

- 13. The formal consultation on the proposals as shown in **Annex 1** was carried out between 24 November and 30 December 2022. A public notice was placed in the Banbury Guardian newspaper, and an email sent to statutory consultees & key-stakeholders, including Thames Valley Police, the Fire & Rescue Service, Ambulance service, Bus operators, countywide transport/access & disabled peoples user groups, Banbury Town Council, Cherwell District Council, the local District Councillors, and the local County Councillors representing the Banbury Grimsbury & Castle, Banbury Ruscote, Banbury Hardwick, and the Banbury Calthorpe divisions.
- 14. A letter was sent directly to approximately 425 properties in the area, which also included a copy of the formal notice of the proposals providing details on permit eligibility and costs. Additionally, street notices were placed on site in and around the area.
- 15. A total of 46 responses were received via the online consultation survey during the course of the formal consultation, and these are summarised in the tables below:

- 16. The above tables are based on the option chosen by the respondent (Object, support etc.) but it should be noted that on reviewing the detail of the responses, in a number of cases a respondent expressing support for the proposal had some qualifications / concerns, and similarly some of the objections related to specific details of the scheme, including the roads not being included in the current proposals, but were otherwise in support.
- 17. Additionally, a further 20 responses were received via email, with Thames Valley Police (TVP), the Local County Cllr for the Grimsbury and Castle division, and Cherwell District Council raising no objection, and the Local District Cllr for Banbury Cross & Neithrop supporting. Eight members of the public raised objections, 7 outlined concerns, and one offered their support.
- 18. The local member for Banbury Calthorpe division, Cllr Reeves, supports the proposals and intends to speak at the Cabinet Member meeting.
- 19. A signed petition was also received from Beargarden Road residents who are opposed to the planned parking layout changes, with 40 of the 55 signatories being residents within the scheme. The action petitioned for was for parking to be kept on the southwest side of Beargarden Road, and to further consult with residents on measures to help improve road safety along the road.
- 20. The full responses are shown at **Annex 2**, and copies of the original responses are also available for inspection by County Councillors.

### Officer response to objections/concerns

21. These officer comments are in the light of the 66 responses received, but are simplified into subject headings to ease analysis:

#### i. That the area of proposals should be extended

The area of the proposed scheme reflects the amount of funding available, but it is also a difficult judgement as to 'where to draw the boundary'. Experience with implementing parking zones shows that parking is typically displaced to the next nearest unrestricted roads, and so care has been taken to set the limit of the scheme so as not to end halfway along a residential street for example.

Future extensions into further areas can be considered, but we would need to monitor the impact of this first scheme, and of course funding would be necessary.

#### ii. One-way street suggestions

There would be no increase in parking spaces as a result of introducing any one-way streets. Crouch Street in particular is narrow with more or less continuous parking on the north-west side. This does make passing difficult for oncoming traffic, and a future review could consider the need

for removing a small number of parking places to assist passage. However, if the road were to be made one-way, there would need to be other complimentary measures that would discourage through traffic; this is because the lack of any oncoming traffic to slow you down could make it more attractive as a through route. Also, depending on which direction the one-way would operate, properties at either end of the road would face a longer distance to travel.

iii. Residents permit charge and the limit upon the number of visitors permits Charges for residents' permits are not new to Oxfordshire, but this is the first scheme in Banbury. It is to be expected that the proposed charge of £66 per year would prove unpopular amongst residents, who currently park free of charge, but the scheme is aimed to benefit residents by improving the availability of parking for them and their visitors. The charge represents a contribution towards the costs of installing and operating the scheme.

The quantity of visitor permits is managed to try to achieve an equitable share of limited parking spaces amongst all residents. An unlimited supply would have an impact on the number of spaces available.

- iv. Loss of short-term parking for visitors for medical appointments or to vets. There is a surgery, a vets practice, and a veterinary hospital within the area of the scheme. Private off-street car parking is available, accessed via Cork Lane (a private street). Part of the proposals replaces the 4-hour time-limited restriction along West Bar Street with permit holder-only parking, and so this would prevent these visitors from parking in the future. As part of monitoring the impact of the scheme, the use of West Bar Street by permit holders will be reviewed and, if it is considered that space is available, then a time-limited restriction for all visitors could be reconsidered.
- v. Loading to medical or veterinary practices along West Bar Street
  Although the time-limited restriction is proposed to be removed, there
  would be no change to the exemption for loading/unloading to take place.
  It may even be the case that parking spaces become more available and
  delivery vehicles find it easier to park.
- vi. The scheme will only work with enforcement
  Cherwell District now has Civil Parking Enforcement. The County
  Council can focus its resources on parking enforcement more so than
  the police were able to previously. Enforcement of the new restrictions
  will be vital and would be given a high priority after an initial period during
  which warning notices would be issued. Currently, enforcement in most
  of the roads within the scheme is suspended, pending the outcome of
  these proposals. This may, in part, explain some of the comments about
  a lack of enforcement.
- vii. The disabled persons' parking place on West Bar Street
  The Windrush Surgery has commented about the need to retain the disabled persons parking place and this is indeed what is proposed. It

is coloured light blue on the plan shown at Appendix 1, and was mentioned in the public notice although it is sometimes difficult to distinguish all the fine details in these legal notices.

- viii. The proposals would displace parking onto Bloxham Road, in the layby This could indeed happen, and casual observations suggest that may already be taking place to some degree. This area would be included in the monitoring of the scheme's impact and, if considered necessary, then Bloxham Road could be considered for an extension of the scheme if funding can be found.
- ix. Why isn't Milton Street included and the surface is in poor condition Milton Street is not an adopted public highway. Even if it were adopted, it is too narrow to be considered for on-road parking. The responsibility for repairing the surface of the road lies with the individual properties fronting each section of the road.

#### x. Beargarden Road

Out of the 46 on-line responses received, 20 were from Beargarden Road residents. The petition also had 40 signatories from Beargarden Road. This is a significant response given there are only 62 properties in the road. The concerns fall into the following categories:

a. The through traffic, road width and turning manoeuvres

The road is used by some through traffic to avoid congestion at the Oxford Road/Bloxham Road traffic signals. There are some existing road humps but this does not offer a deterrent to such extraneous through traffic. The width of the road varies but is 5.9m at its narrowest point. This allows through traffic to pass a parked vehicle (allowing 2.0m for a parking space). Some of the respondents are concerned about parking on both sides of the road, but the proposals would not permit this, unless a vehicle is exempt from yellow line restrictions (e.g. for loading purposes); however, that is already the case with parking being unrestricted on one side and yellow lines on the opposite side.

Turning into/out of the side roads has been protected in the proposals by use of double yellow lines either side of junctions.

#### b. Parking across driveways and deliveries

The existing unrestricted parking, currently on the south-west side of the road, does mean that residents can park outside their own driveways. However, that essentially means the space can only be used by the property concerned, which already has the use of a driveway, whereas most properties on the north-east side of the road have no off-road parking facility. Deliveries will still be possible despite the proposed new double yellow lines, as they are exempt from the restriction.

c. <u>Speed of traffic, road safety and visibility from side roads</u>

Beargarden Road is situated on a hill, so vehicles travelling downhill would need to allow more time/distance to brake. As part of

implementing the proposals, it would be possible to repaint the triangular warning markings on the existing road humps, but there is no funding for further speed-reduction measures. It is anticipated that most residential streets in Banbury will be considered as part of the 20mph speed limit programme in due course.

Road safety is a consideration in designing parking schemes, but it is also a balanced consideration between allowing parking spaces and the free movement of through traffic. Occasionally, parking layout can be used to reduce vehicle speeds directly, but this is not the intention with these proposals. Instead, the proposals main aim is to increase the supply of parking spaces for all residents, including their visitors. The scheme will be monitored and if visibility is causing severe problems, then further yellow lines can be considered.

#### Monitoring and evaluation

22. It is suggested that a review of the scheme is carried out approximately 12 months after its implementation, should it be approved.



(3) Local District Cllr, (Banbury Cross & Neithrop)	Support – While we would welcome the introduction of CPZs in Banbury town centre, we do not think the area proposed in the consultation is extensive enough. While knocking on doors in the town centre, we consistently get requests from residents not only in the area earmarked for the scheme, but also from residents on the other side of South Bar Street and Oxford Road, comprising the following streets: St John's Road, Dashwood Road, Calthorpe Road, Newland Road, Prospect Road, Grosvenor Road, Albert Street, Marlborough Road, Brittania Road and Gatteridge Street.  We wondered, therefore, if the consultation in Banbury could be extended to include those streets.

Keeping some space for residents is good, but there are very few available parking spaces for others who also need them.

#### New parking restrictions:

We believe the proposed changes will create a complex situation with traffic and not provide solution for the flow of vehicles, complexities on double way, deliveries, driving out from driveways or junctions.

Monument Street (Northwest side): Object, Monument Street (Southeast side): Object that streets' permit provides much needed waiting time for many purposes. Prohibiting them will be counterproductive.

#### Scheme in general – **Object**

I still don't understand why paying to park on my own road will benefit me. Limiting the area to residents only doesn't automatically guarantee that I'll find a parking spot on my area, as it could still be taken by my "neighbour's visitor". The limitation of the spaces is still a reality, you are not increasing the parking places, and it'll make more people angry in the long run, especially when they couldn't find a place where to park after having paid £66 a year.. which, by the way, I believe the Council reserves the right to increase this fee anytime in the future. No, no and no. It's a money maker!

I can only assume that the person who thought of these changes has never actually been to the road to see how this would work in practise. You can only just fit two cars side by side

on each driveway along the road. There is a low wall between each driveway. Both cars are used daily to travel to work and for this we require going down the hill towards West Bar Street. Whichever car is unlucky enough to be parked on the left of our driveway (if you had your back to our house), would no longer be able to turn left, as if there is a car parked opposite our house then we would not have enough room to pull out and miss the wall that divides each person's driveway. Both of our cars also require electric charging, for which we're about to get an electric charging point fitted on our house. If this is to go ahead, only one of us would be able to park on the driveway and the other would have to take up one of the parking permit spaces, in order that we can both get to work without turning right up the road and go on a complete detour just to avoid crashing into the wall/the car parked opposite. This surely defeats the object of having more parking spaces available, as I'm sure other residents would be in the same situation. It also means not both of us could charge our cars at the same time. We bought a house with a double driveway in order to use it, not to be faced with this situation where it logistically does not work so we can't park both cars on our own driveway.

The road is also used as a rat run at busy times and is dangerous enough as it is. There are so many near misses (and actual crashes) with people honking at each other throughout the day. This will only exacerbate that problem. The road is also used as an emergency services route. If there isn't room for two way traffic to pass, this can only make an already tight road inaccessible and makes what is being proposed unviable.

West Bar and Crouch Street are also already extremely overcrowded and people park over the double yellows every single day. I don't understand how changing the rules to parking permits will change this.

#### Amendment of parking restrictions:

Monument Street (Northwest side): No opinion, Monument Street (Southeast side): No opinion I don't know enough about what these are currently to comment on them.

(8) Local resident/Member of public, (Banbury, Beargarden Road)

#### Scheme in general – **Object**

Having lived in the street for over 20 years we have seen these proposals before. The same problems still exist, Cars driving too fast down the street towards West Bar Street - No proposal to deal with that (a speed bump needs to be installed near the Crouch Street junction. Make the street one way, making cars drive up Beargarden Road towards the Health Centre would be sensible. The lack of parking at the health centre is the major issue and that has been caused by the planning department allowing a large building with inadequate parking. If the council do make the street residents only parking, but I strongly object to the to double yellow lines being put on the Northwest side of the street. You will not be gaining any more spaces because those household that have a drive but have more than two cars will be adding to the problem as they will not be able to park a car across their drive.

#### New Parking places:

Currently if something is being delivered to our house then a lorry can park across our drive to deliver the good, under the new plan then they would need to park in one of the loading bays to deliver my goods!!!!

#### New parking restrictions:

Beargarden Road: Object, Crouch Street: Object, New Road: No opinion, Statement 4: Object, West Bar Street: No opinion

Putting double yellow lines on the opposite side of Beargarden Road is dangerous. It is hard enough seeing what is coming when you turn out of the Crouch Street junction. If the changes come in, then anyone wanting to see what is coming down the road will have their view restricted by cars /van parked on the Southwest side. It only takes a car coming down Beargarden Road that is being driven by someone who thinks they are driving down Silverstone Racetrack and a car pulling out of Crouch Street that cannot see or be seen as a van is parked in the first available space and for an accident to happen. We are a four-car household that has a driveway, we park two cars on the drive and one car across the drive meaning we only use one space on the road. With the new proposals we will have to take up two spaces, so adding to the congestion and having to pay for the privilege of parking two cars on the road. Beargarden Road is used by children and adults going to Harriers, BGN & amp; Wykham Park twice a day for 38 weeks of the year. Small children are allowed to run or scooter down the street under very little supervision. Unser the existing plan there is some protection from the bollards on the Southwest side and parked cars on the Northwest (keeping the children from being on the side of the road. under the new proposals means there will be no protection on the Northwest side. The young adults going to the secondary school congregate on the corners of Crouch Street again causing viewing up the street to be restricted. The main issue with parking is the staff and visitors to the health centre as it has inadequate parking on site. I do not believe that making the street residents parking only will stop patients who have a doctor's appointment / picking up a prescription from parking on the street. They block our driveways and when questioned they say, "I had an appointment and there were no spaces available in the carpark "At the weekends the street and is very quiet and with very few parking issues.

#### Removal of parking restrictions:

Currently there are no waiting restrictions on the Northeast side of the road and they should stay this way. Putting double yellow lines across my driveway will mean anyone there will be parked cars on the opposite side of the road making reverse parking on my drive difficult (we have a large estate car)

Declaration of Interest: I have an interest in properties and businesses operating from 9-13 West Bar Street and at West Bar Veterinary Hospital, 19 West Bar Street.

Objection to the Proposal:

Parking on the south side of West Bar is historically difficult. Properties from No 9 to 13 West Bar Street are shared business / residential use and from number 19 onwards onwards are all business properties including a large veterinary hospital and a medical practice at 19 and 21 West Bar.

I have 2 reasons as to why this scheme should be altered.

Firstly all of these businesses to the south of West Bar have a steep gradient between their northern and the southern property limits. This steep gradient causes problems with large or heavy deliveries to these properties, in particular supplies of medical oxygen. As you can appreciate medical oxygen is a essential requirement for medical and veterinary services.

Oxygen cylinders are transported on large flatbed trucks/lorries. The Medical Oxygen is delivered in cylinders which by their nature are very heavy and have to be handled very carefully. If they are damaged in transit they can cause considerable harm / personal injury. Oxygen is typically delivered in large 'J' cylinders which have a weight of around 80kg and are about 1.5m high. They contain pressurised oxygen at around 140bar. Medical Oxygen suppliers have told us that are significant health and safety issues caused by the gradient and that they are unable to deliver oxygen cylinders via the access on the southern property boundaries. These large cylinders have to be manoeuvred into the premises on wheeled trucks on a largely level surface which is only possible with direct access to West Bar from the front of the properties to the lorries transporting the supplies. The gradient of the properties mean that other large or bulky medical supplies equipment also have to be delivered via the northern frontage of the properties on West Bar. Large deliveries occur several times each week. Secondly the steep gradient causes significant problems for a number of people who require assistance to get into the doctors' surgery or veterinary hospital. Southern access to the doctors practice is via a series of steep steps

and to the vets by a slope. Clients of the medical and veterinary practices experiencing difficulty in using the steps or slope use the more level front access direct from West Bar. Not all of those experiencing difficulty are Blue Badge Holders.

Both the Doctors surgery and Veterinary Hospital provide vital local services to the Banbury community. I would therefore request that in your parking plans you make two changes.

Firstly I would ask that you make sufficient provision for the loading and unloading of vital medical/veterinary supplies/equipment including Medical Oxygen from West Bar Street. My proposal would be that the current southern roadside outside properties number 9-13 West Bar becomes a designated loading / unloading zone. A clear loading zone in this location would also facilitate the emergency services. It is my experience that ambulances / emergency vehicles attend the medical practice frequently. If the residential parking was extended to the east along West Bar as proposed there would be nowhere for ambulances to park (except the bus stop area) without causing considerable congestion on West Bar. Ambulances do not use the Southern access to the doctors' practice due to having to move patients up a series of steep steps.

Secondly I would suggest that most (if not all) of the properties to the South of West Bar have sufficient private parking and in my view it would make more sense if rather than converting the existing 4hr parking limit to residential parking that this is reduced to 2 hours parking limit which would give clients of the businesses along West Bar sufficient time to park, easily access and transact their business at the various professional business along West Bar.

I trust you will seriously consider my objection and proposals.

As well as these 'near misses' there have unfortunately been a number of actual collisions in recent years, to which any of my neighbours will attest. The visibility is severely restricted when pulling out of both Cork Lane and Crouch Street and to block the view even further by adding parked cars to the left and the right is just nonsensical. If these plans go ahead, there will no doubt be more vehicle collisions, not to mention an increased risk to pedestrians that use the road - in particular families with young children on their way to and from surrounding schools.

In addition, Beargarden Road is used by ambulances responding to emergency calls on a daily basis. It's already hazardous and needs to be exited with extreme caution. I exit such road daily and I'm very concerned for the potential lack of visibility should permit holder cars be parked on the new proposed side of the street. Furthermore it will be very difficult once pulled out into beargarden road to find a suitable 'pull in' spot should you meet oncoming traffic as the homeowners drive way entrances forbid waiting across such and most of such stretch of beargarden road is infact dropped curb drive ways.

It's impossible for most normal sized vehicles to exit milton street via the new road end as presently the lamp post/metal pole embedded in ground next to it and large (conservation area) brick wall opposite to junction means turning is incredibly tight, if not impossible. Several vehicles have been damaged attempting such.

If you have not physically attended the junction I urge you to , ideally in your own vehicle, whilst trying to exit Milton street into beargarden road to fully appreciate how difficult such manoeuvre is to do safely, especially at the height of the school run where a great deal of children are either on foot/ bikes/ scooters or in cars travelling to the primary (St. John's priory/ Harriers primary school) & secondary schools (BGN/ Banbury school) very close by.

# (52) Residents Association, (Banbury, Upton Court)

**Object** – I have responded to the survey officially but felt it appropriate to raise concerns on behalf of 23 residents of Upton Court.

The proposal to allow parking to the North and South of the entrance/exit to Cork Lane is without doubt objectionable. The current visibility when exiting that small side road is severely limited - any current vehicle parked either left or right illegally prevents vision. If the vehicle is parked to the left you cannot see over it because this road is on a hill so you would be pulling out blind to the wrong side of the road whilst making sure no-one hits you from the right coming up beargarden. Turning right you cannot see past parked vehicles because the road curves so nothing is visible. At the moment it is virtually a non problem as no one parks on the double yellows.

This road is a rat-run in the morning so the speed will just be opened up for people as you will change the traffic priority to downhill rather than uphill which naturally reduces speed at the moment. Drivers would not be able to see the junctions between the parked cars at 3 junctions on this road according to the plan despite the distances as the cars parked would obscure the view due to the road curve and hill.

Ar present our objection is very strong to this proposal concerning beargarden changes and verging on offensive that this bulldozes the actual people resident in this area. You don't put speed bumps in when we asked, you don't ticket cars parked illegally anyway yet you spend money on this work!?

**Object** – I am a resident of Beargarden Road in Banbury and would like to raise my concerns and therefore my objections to the new proposals as set out in the Consultation paper for Banbury centre-west Proposed Controlled Parking Zone.

I do not agree with the aim of the CPZ that the supply of on street parking will be better managed for the 'benefit' of residents and their visitors, it will be LESS beneficial for several reasons.

Firstly there are at least 25 houses on the South side of Beargarden road and by moving the parking to the opposite side of the road where there are 3 junctions crossing it is decreasing the amount of parking spaces for residents and their visitors - you propose just 21 parking spaces? These spaces are dangerous and appear somewhat illegal being so close to the junctions of both Cork Lane, Crouch Street and Milton Street. Not only by moving parked cars to the other side of the road where the junctions are, traffic pulling out of those junctions now has to emerge into free flowing traffic to pull out as visibility will be decreased by cars on each side of the junction.

I acknowledge a proportion of these spaces can only be used by the residents of the homes who have dropped curbs and white lines outside their home. Whereas the 8 houses and flat on the other side of the road have to share parking spaces in the areas without a dropped curb. Therefore, these homes will argue this proposal will increase spaces for them. However, if you take into account all the spaces that are used by all the residents, the new proposal will reduce the 37 spaces to 21. This can be evidenced by the fact that I and my neighbours use the parking spaces with dropped curbs every day to most days. Therefore, the new parking permit proposal will mean more cars will be fighting to use less spaces.  • To put two cars onto our narrow driveway, currently requires a large area to swing into the drive. By having cars parked on the other side of the road, to put two cars on the drive will near impossible. Therefore, now from our household only two extra cars will need to park in the permit zone which will increase the number of cars looking for available spaces.

- As my household will no longer be able to use the other side of the road to turn into my drive, will result in my household needing to make timely multiple manoeuvres to turn into the drive safely. In turn the timely multiple manoeuvres of going in and out of a driveway will impact other drivers coming down the street and this will cause delays and obstructions. As Beargarden Road is a major "rat run", road used on a regular basis as a detour route, when road works are being completed and ambulance route, I feel this issue needs consideration.
- When the residents of Beargarden Road asked for chicane's to be installed we were denied this request on the basis Beargarden Road is an ambulance route and we were told it cannot be blocked at any point. However, the proposed changes will create more blockages on the road for other drivers and residents caused by:
- o Delivery drivers needing to stop to deliver parcels, food etc. Where currently they can find spaces outside on the southwest of the road.
- o Daily Grundon commercial waste disposal lorries needing time and space to reverse in and out of Cork Lane. Currently without having cars parked on each side of the northeast side, the waste disposal lorries struggle with this daily turn.
- o Residents needing extra time and space to turn in and out of their drives, as previously stated o Less spaces for road users driving on the other side of the road to wait for passing cars. This is due to the majority of the road being one car wide.
- We have been reliably informed that the proposed changes will negatively reduce the value of our home. Where the other homes who will now have parking if the proposal goes ahead will increase in value. I have been informed OCC councillors do not take into account the monetary impact of their decisions upon the effected residents as this decision is based upon available parking as per the Traffic Management Act 2004. However, I would like to argue ignoring the negative financial impact upon the majority of residents contravenes s2 (f) Care Act 2014, which the local authority has a duty to uphold
- I have lived in my property for over 23 years. During this time my mother has visited most days to spend family time together. In addition, other family members and friends also visit on a regular basis. They are able to do this by, parking outside my home. I would argue on a personal level these proposed changes are direct violation of my right to a continued family life as per Article 8 European Convention of Human Rights 1998. As when the parking permit zone comes into force, my mother, I will only be allowed 50 parking visits from others a year.
- The additional number of cars needing parking spaces through these proposal will result in more cars parking in South Bar Street where they will have to pay, or a long walk away to Mewburn Road estate. Both options are too

far for people to walk who have an impairment though are not eligible for a disability badge, to carry shopping or young children. On a personal level my in laws are not eligible for a blue badge as they can walk further than 50 meters. Though both would struggle to walk 100 meters. As Crouch Street is 200 metres in length, they would not be able to park in South Bar and walk up this road. As the distance from my house to an available space in Mewburn road is 140 meters, again this would be too far for them to walk. Therefore, this proposal again impacts my right to a continued family life as per Article 8 European Convention of Human Rights 1998. Whilst my in laws right to accessibility and Full and effective participation and inclusion in society is impaired as per Article 3 (c)(f) European Convention of the rights of persons with disabilities.

- The path on the northeast side of the road in Beargarden Road is too small for a person to exit a car safely especially a disabled person or those with young children.
- The junction of Cork Lane and Crouch Street onto Beargarden Road, are currently very dangerous, as drivers need to pull out quite far into the road to see if cars are coming before they pull out. As currently there is substantial reduced visibility at these junctions. Putting parking spaces on either side of these junctions will result in drivers needing to pull out into the centre of the road to see if a car is coming. This is a danger and a possible obstruction to others. I would argue this
- By changing the side, the cars are parked on will result in cars speeding down the hill on the southwest side and causing accidents. This claim by be supported by the numerous traffic accidents that have occurred in Beargarden Road. The council previously responded to the road traffic incident rate in Beargarden Road, by installing bollards on the northeast side of the road for pedestrians protection.
- Beargarden Road is a major route for children going to Harriers primary school, BGN secondary school and Banbury school. Many of the children who go to these schools walk on their own. As all parents know for the children to walk safely to school, the children should walk on the side of the road that is protected by cars. The proposed parking permit zone changes will result in children needing to walk on the narrow path on the north east side as this will be safer as they will be protected by the cars. Furthermore, the path on the northeast side is not wide enough for two people to walk side by side. This creates difficulties for parents needing to hold onto their child's hand. Additionally, the children will then have to cross Beargarden Road at some point to reach their school. As Beargarden Road is a 'rat run', there is a concern children could be harmed crossing the road. Currently children can walk safely on the southwest side of the Beargarden Road as they are protected by the cars who park on that side

	<ul> <li>A narrow turning from the road into the drive will impact our ability to have a skip on our drive for any building works we want to complete. Though the skip could have a permit and be on the road, again this will create additional costs, that would not have been present before, as the skip could have been put on our drive for free.</li> <li>As there is only going to be 37 spaces reduce to 21 spaces, there is a high probability neighbours will start arguing over the reduces spaces. This will cause upset in a community that up till now has always got along.</li> <li>I would argue by having set times where anyone can park in the 21 spaces, will become known in Banbury as 'free town parking'. This will create more difficulties for the residents as there will be nowhere to park in the street.</li> <li>Finally, why is South Bar in Oxford Road not being considered for residents parking permits, as for those living in Crouch Street and Milton Street, it is the same distance to walk there?</li> </ul>
(57) Local resident/Member of public, (Banbury, South Bar Street)	Object – I have received a formal consultation letter regarding Banbury centre-west Proposed Controlled Parking Zone (CPZ). I would like to object to these proposals.
(58) Local resident/Member of public, (Banbury, Beargarden Road)	Object – Please note my objection to the proposed change to parking in Beargarden Road.  My main objection is based on safety. If parking is switched to the opposite side, then visibility will be restricted for cars coming up Crouch Street turning into Beargarden Road especially looking up Beargarden Road. I've seen a number of accidents and close shaves as it is, but putting another obstacle in the way will only lead to more accidents in the future. I have based this on the fact that I have lived in the street for over 20 years now.
(59) Local resident/Member of public, (Banbury, Westbeech Court)	Concerns – I wish to give some information about Westbeech Court that will prove pertinent going forward.  Of the 32 original properties (three extra houses have since been built), around only 22 have access to garages. Of these, many are not in use for cars, being used for housing storage instead. Thus those cars use the existing residents parking bays as well as those residents that have never had access to a garage.  There aren't enough spaces regardless of if there is a parking scheme or not, thus residents have to park on the verges of the double width pavement.

This has been exacerbated by the construction of the three new houses (Oak, Willow, Beech) which took away four / five parking spaces against the old wall.

Westbeech Court itself is a single width carriageway. With the paths being double width, there was discussion before in the Court, to move forward with requesting that the pavements be made into single width to allow cars to park.

This was back before the three houses were built. When the area of land behind Aplins (subsequently used to build on) came up for sale, that the thought for some arrangement for Westbeech Court parking. This thought disappeared when the land was sold for development (15/0300/F and 15/01144/F), even though that development was rejected by CDC and was only approved after being appealed to the Planning Inspectorate at Bristol.

That even if all the paths wouldn't be made into single width, that the three car area as highlighted in yellow on the map below would be converted into marked parking bays.

It is understood that the freehold of Westbeech Court itself is held by Freshwater. That the paths and roads are adopted by OCC under a Section 38.

I hope this gives some more information on the existing problem.

(60) Local resident/Member of public, (Banbury, Beargarden Road)

**Concerns** – I am the owner of two properties in Beargarden Road, Banbury, OX16 9PJ which will be affected by the proposed controlled parking zone. My properties, 11 and 13, which are currently undergoing extensive refurbishment work in order to bring them to a higher and more modern standard, have a vehicle access between the two properties which is defined by two blue wooden doors. Behind these doors there is space to park at least two to three vehicles. Once the properties are fully refurbished in 2023, they will be available for rent and the occupants will have a legal right to access this area between the two properties in order to park their vehicles.

I understand from reading the recent letter sent to the properties in Beargarden Road that the double yellow lines that are currently in front of the properties are to be removed and put on the opposite side of the road. This is to allow permitted parking outside my above two properties. I also understand from point 1(a) that parking will NOT be allowed outside the blue gates. I would be grateful if you could confirm that this is the case as access is required here twenty four hours a day for the reason stated above.

(61) Local resident/Member of public, (Banbury, Milton Street)	Concerns – Having received your letter regarding the above subject, I have great concern where I will be parking both my company vehicle and family car which both are being used daily parked on Beargarden Road if you proposed is agreed. I need confirmation on the following:  1. A confirmed parking for Milton Street vehicles? 2. Can you conform if Milton Street was considered in the proposal? Although not mentioned in your letter.  This is a serious matter and I believe the Milton Street was not part of your proposal.
(62) Local resident/Member of public, (Banbury)	Concerns – have two concerns which I would like to raise with you.  1. Parking Place – Addition of 6 car length spaces on West Bar Street As a local resident and a daily user of this stretch, I find this proposal to be misguided and potentially dangerous. With the existing parking arrangements, it is already a very tight squeeze to get two cars to pass concurrently along this stretch. If even one vehicle is parked illegally at the north-eastern end (which is a frequent occurrence), and you meet a van or larger vehicle coming the other way, it is virtually impossible for the two ways of traffic to pass at the same time without stopping.  By adding six additional spaces this will only compound the problem. The extra parking would then have the knock-on effect of reducing visibility to see on-coming traffic, resulting in a greater risk of accidents and damage to parked vehicles. There would also be the resultant delays, with traffic queues likely to form in both directions as two vehicles could not pass through at the same time. I am sure if you do the appropriate measurements you will come to the same conclusion.  I do not believe this would be helpful on one of busy arterial roads in and out of Banbury. I would be interested to know whether this has been reviewed from a health and safety perspective. Has a risk assessment been carried out?  2. Residents Only Parking in West Bar Whilst I absolutely agree in principle with the introduction of permits for residents along this stretch, I fell you must maintain some facility to be able to drop off visitors to Windrush Surgery. I know the Surgery has parking at the rear of the building, but under your proposals there would be no facility to drop off disabled visitors at the front of the building, where the disabled access is.

	As an example, when dropping off my 89-year-old mother, who cannot manage steps, the only option I have is to drop her off at the front of the building and then park at the rear whilst she is inside.  Could you not keep/replace the current disabled bays and introduce a 5 min drop off space to accommodate these cases?
	In summary, I believe that if these proposals were to go ahead, this would lead to: -  • Potential of more traffic accidents on West Bar  • Potential of greater damage to parked vehicles on West Bar  • Increased road congestion on West Bar, as the two-way flow of vehicles would be virtually impossible  • Create difficulties for disabled users accessing Windrush Surgery
(63) Local resident/Member of public, (Banbury, Milton Street)	Concerns – I live on Milton Street, and have 2 parking spaces of my own at the side of my house, on New Road. We have suffered major disruption here over the last couple of years, due to a development on New Road, and another development is now in the pipeline for further up New Road. Have you visited this road at all - and become aware of its narrowness? (If not, I suggest you make a plan to come and see for yourself asap!)
	My thoughts are:  • The road surface is in a very disreputable condition - potholes galore - so before any yellow lines are painted it needs resurfacing.  • If there's to be 'No Waiting at Any Time' down the length of New Road - what about Refuse Collection Trucks, Taxis, Delivery Vans (DPD, etc), all of which are frequent visitors here?
	I wish you well - and hope the resulting regulations will improve the lives of us local residents, rather than impede them
(64) Local resident/Member of public, (Banbury, Beargarden Road)	Concerns – I thought I would contact you highlighting my concerns, reference the proposal for a restricted parking scheme.
	Beargarden Road (The future) This is going to be the norm if the scheme goes ahead as planned, as you are aware the width of the road (Kerb to Kerb) is approximately 6.7 metres wide, cars parked on either side of the road will leave a gap of 2.5 metres this is huge concern.

- Leaves no margin of error for Fire engines that have a width of 2.3 metres, leaving a clearance of 0.2 metres, could well be less if cars aren't tight to the kerb.
- Margin of error for a standard UK dustbin lorry is even less, not because of the width but due to the fact they have to enter Cork Lane, standard width of the lorry is 2 metres. Because of the nature of the collections the road in effect will become a one way street and cars entering from the opposite end to which the lorry is working will realise there is no passing point. ( Reversing will be the only option )
- Cork Lane is the entrance to the Doctors surgery and the Veterinary practice and has a busy flow of traffic , emergency vehicles will find it very difficult to enter the lane .
- Coaches and HGV's all travel down Beargarden Road there will be no option for this type of traffic to reverse, it will create chaos.
- Cork lane and Milton Street both have very tight entrances (see attached pictures), entering Beargarden Road from them will be extremely dangerous and a significant hazard.
- Home deliveries from Argos , Sainsbury's Tesco's , Amazon etc will just block the road and will increase congestion in an already busy street.

Rule 242 of the Highway Code states you must not leave your vehicle or trailer in a dangerous position or where it causes unnecessary obstruction of the road – I would argue the Cork Lane and Milton Street entrances will create a hazard and potentially a dangerous situation.

Rule 243 States that you cannot stop or park anywhere you would prevent access for emergency services , the scheme has a high chance of doing this.

Also states you cannot park opposite or within 10 metres ( 32 feet ) of a junction , the scheme will contradict this .

It also states you cannot park in front of an entrance to a property how do you plan to stop vehicles parking in front of the electric sub station ?

The street is a constant short cut for vehicles coming from the Bloxham road (into Beargarden Road) from the Oxford Road (coming up crouch street to Beargarden Road) and from Broughton Road (into Beargarden Road)

	I really am struggling to see how chaos can be avoided once the scheme is implemented, we constantly see irate and frustrated drivers so the scheme is just going to add to the problem.
	Will the permits be personalised to a particular property ?
	Can I ask did you hold a consultation meeting with the residents? If not, why? If you did, when was it?
(65) Local resident/Member of public, (Banbury, Broughton Road)	Concerns – I live on Broughton Road and do not have any parking for my 1 small vehicle. My house is one of three in a terrace which does not have parking. It is located very close to West Bar and adjacent to Bear Gardens Road. I currently have to find parking in the neighbourhood roads it would help me enormously if I was able to get a parking permit. For this reason I would be very grateful if you could include me within the parking permit application.  I would also like to suggest that electric vehicle charging sites are included within this the new parking scheme.
(66) Local resident/Member of public, (Banbury, Crouch Street)	Support – I would like to express my strong support for the proposal as a resident of one of the affected roads.
