**BURFORD PRIMARY SCHOOL.
CHANGE IN THE AGE RANGE OF
THE SCHOOL.**

Notice is hereby given in accordance with section 28(1) of the School Standards and Framework Act 1998 that Oxfordshire County Council intend to make a prescribed alteration to Burford Primary School, Priory Lane, Burford, Oxfordshire, OX18 4SG by changing the age range of the school by a year or more from 01 September 2007. The number of three year old places will depend on the number of four year olds on roll at the School.

The current age range of the school is 4 years to 11 years.

The proposed age range will be 3 years to 11 years.

The number of pupils to be admitted to the school at age 4 from 01 September 2007 and subsequent years will be 15.

There will be no capital costs as the School has recently completed work to provide a high quality indoor and outdoor environment suitable for the youngest children. By admitting children age three into the Unit ,the School will be able to provide continuity of learning for children throughout their Foundation Stage .

Funding for revenue costs will be made available through the school's delegated budget from the Local Authority.

Within six weeks after the date of publication of these proposals, any person may object to or make comments on the proposals by sending the representations to
