**CHANGE IN THE AGE RANGE OF
THE SCHOOL**

Notice is hereby given in accordance with section 28(2) of the School Standards and Framework Act 1998 that The Governors intend to make a prescribed alteration to Charlton-on-Otmoor Church of England Primary School, Church View, Fencott Road, Kidlington, Oxfordshire, OX5 2UT by changing the age range of the school by a year or more from 01 September 2007. The number of three year olds admitted to the school will depend on the number of 4 year olds on roll.

The current age range of the school is 4 years to 11 years.

The proposed age range will be 3 years to 11 years.

The number of pupils to be admitted to the school at age 4 from 01 September 2007 and subsequent years will be 15.

The proposals are supported by the local authority which is also the admissions authority for the school. The proposal will be implemented by the governors and the county council. There are no capital costs arising from the scheme because the school already has a purpose built unit currently being shared with the local pre school which will close. Funding for three year olds on the pre school roll will cease and the revenue costs for these children will be made available through the schools delegated budget from the Local Authority.

Within six weeks after the date of publication of these proposals, any person may object to or make comments on the proposals by sending the representations to
