### LAUNTON CE PRIMARY SCHOOL- CHANGE IN AGE RANGE OF THE SCHOOL

Notice is hereby given in accordance with section 28(2) of the School Standards and Framework Act 1998 that the Governing Body intend to make a prescribed alteration to Launton Church of England Primary School, Bicester Road, Launton, Bicester, Oxfordshire, OX26 5DP by changing the age range of the school by a year or more from 01 September 2006.

The current age range of the school is 4 years to 11 years.

The proposed age range will be 3 years to 11 years. The numbers admitted at 3 would depend on the number of F1 children already in Foundation Stage Unit. This would be no more than 20 F2 children (3 year olds) during a year.

The number of pupils to be admitted to the school at age 4 from 01 September 2006 and subsequent years will be 24.

Funding for revenue costs will be made available through the school's delegated budget from the Local Authority. Any capital costs will be met by the school. The Governing Body is publishing this prescribed alteration in order to regularise existing practice. Currently children begin school at a single point entry in the September of the year they are five. In addition to this Autumn born children begin school part time in the Spring term before they are five (ie term 3) and Spring born children begin school part time in the Summer term before they are five (ie term 5). The school plans to maintain this without change.
