# OXFORD, PHIPPS ROAD – PROPOSED RELOCATION OF HIGHWAY GATE

## **Report by Head of Transport**

#### Introduction

1. Requests have been received, through Oxford City Council for the highway gate located in Bailey Road to be relocated to Phipps Road. The reason put forward for the relocation of the gate was to remove the rat-running traffic from these roads. A survey carried out by Oxfordshire County Council showed approximately 64 vehicles in the am peak and 75 vehicles in the pm peak use this route at speeds considered to be dangerous.

# **Background**

- 2. At its meeting held on 1 November 2006 the Cowley Area Committee considered a City Council report on requests for the highway gate located in Bailey Road to be relocated to Phipps Road. The results of that report suggested that out of 137 questionnaires returned 70 agreed that the gate should be moved, 39 disagreed with a further 28 who had no strong opinion or preferred an alternative solution. A copy of the report is included in the background papers.
- 3. The Cowley Area Committee agreed that the proposal should be taken forward to formal consultation and at that meeting Oxford City Council agreed to fund the cost of implementation.

#### Consultation

- 4. Formal consultation was undertaken over a four-week period between 16 April to 11 May 2007. Letters were sent to all residents in Bailey Road, Boswell Road, Frederick Road, Knowles Road and Phipps Road, as they would be directly affected by the relocation of the highway gate, along with standard consultees and local City and County Councillors. Street notices were also erected on site at the proposed location and notice put in the local paper. The proposal is shown on the drawing at Annex 1.
- 5. Sixty-two letters of comment were received. 18 supported the proposals and 44 objected. Out of the 44 objections, 19 were received in the form of a petition (Annex 2).

6. Officers have taken all responses into consideration and have summarised the responses received along with officer comment at Annex 3. Copies of the letters received are available with the background papers in the Members' Resource Centre.

#### Conclusion

7. In view of the significant objection towards the proposed measures I consider that the scheme should not be implemented.

# **How the Project Supports LTP2 Objectives**

8. The scheme, if implemented, would contribute to one of the LTP objectives (Improving the Street Environment) by removing through traffic. However, this benefit may be lost if the local residents have to make longer journeys by car using the adjacent congested road network.

# Financial and Staff Implications (including Revenue)

9. Funding for the scheme would be provided by the City Council. There are no staffing implications.

#### RECOMMENDATION

10. The Committee is RECOMMENDED not to approve the relocation of the highway gate from Bailey Road to Phipps Road as illustrated in Annex 1 to this report.


