#### 7. Details Pursuant to Condition 22 (perimeter fencing) of Planning Permission P11/W2208/CM (MW.0015/12) at Woodeaton Quarry, Woodeaton - Application No. MW.0105/16

##### *Additional Representation*

1. Since writing the report, the Headteacher of Woodeaton School (Anne Pearce) invited the case officer, Cllr Anne Purse, the applicant (Michael Mckenna) and chair of school governors to an onsite meeting to discuss the proposed perimeter fencing on the 21<sup>st</sup> November. As the school wanted to find the best solution to the fencing issue.
2. At the meeting and site visit to walk the perimeter fencing, Michael Mckenna showed the finished perimeter fencing to south-east corner and proposed a change to the proposed fencing scheme on the southern boundary.
3. The proposed changes to the fencing proposals are as follows:

The length of fencing along the southern boundary of the quarry shown in orange on drawing no.: 136MWQ/8 Rev B as far as the now boarded up old entrance gates (identified in green on drawing no.: 136MWQ/8 Rev B) will comprise 1.9 metre deer proof mesh fencing and 3 three strands of barbed

wire on angled brackets above (with the cranked angle top facing towards the road). Plain wire strands will also be threaded through the deer proof fencing to give it extra strength.

4. The representatives from the school and Cllr Anne Purse advised that they were happy with the scheme if it were to be amended as discussed at the meeting and site visit. The case officer is currently waiting on a revised Fencing Plan to reflect what was agreed at the meeting and site visit to be produced by the planning agent. This will be made available at the committee meeting.

*RECOMMENDATION*

***It is RECOMMENDED that subject to no over-riding issue being raised by outstanding consultees, the revised fencing details set out in Application MW.0105/16 be approved.***
