Child Safeguarding Practice Review: Jacob

- Title " Untouchable Worlds"
- Summary with analysis not descriptive detail
- Family & professional participation & collaboration



Jacob's Story (July 2017 - April 2019)

"Nothing changed to keep Jacob safe"

- Range of statutory and voluntary services / significant number of professionals
- A child that lived at home (shared care) and in care
- Not on roll and not in education for 22 months
- Extensive police records for alleged offending behaviours that did not meet threshold to be placed before the courts
- Significant physical injuries
- Assessed as being a risk to himself and others
- Drug and alcohol use not fully known
- Repeatedly missing from home and care
- Family and professionals held the view risk came from community, cannot determine with reasonable certainty he intended to end his life



The report found.....

- Some good practice relationship based; risks & information shared; addressing sufficiency of placements
- Criminal Exploitation he was significantly harmed and exploited
- The Education System Jacob was let down
- Working together was fragmented and did not achieve positive change



Key Learning: Criminal exploitation

<u>A system designed to support those working with criminal exploitation must:</u>

- Ensure safer communities which keep a relentless focus on disrupting perpetrators and networks
- Consider the child's home in the local community and assess what other places might be needed to ensure their physical and psychological safety
- Support professionals to build relationships with children and understand their world
- Act upon critical and reachable moments in a child's life

• Consider the significance of gender in working with exploited children



Key Learning: Criminal exploitation

Practitioners should:

- Know the risk factors and predictability
- Understand the significance of a child's identity within their community networks when assessing levels of risk
- Manage risk via multi-agency assessments, plans and contingency
- Ensure the right support to help families and manage the risks together
- Review the role and function of the National Referral Mechanism
 Have a national drive and agenda for children at risk of exploitation



Key Learning: Education

The Education System must ensure:

Page 8

- The paramount importance of the role of schools in keeping children safe
- An education package is put in place in a timely manner
- Children not in education/not on a school roll are known and action is swift



Key Learning: Working Together

- Involve ALL the local safeguarding system
- Effective discussions at all levels of seniority which result in collective responsibility
- Robust systems which facilitate resolution when opinions differ
- A shared language across the partnership





- 1. The National Panel to acknowledge and share this Review with key organisations and agencies to inform national policy and practice
- 2. DfE to acknowledge this Review / look at effectiveness of ESFA / statute & guidance to local areas re: governance of academy schools
- 3. DfE to undertake a review of national placement sufficiency





One local recommendation linked to the three key lines addressed through three system wide action plans

- Child exploitation
- Education
- Working together



Tackling Criminal Exploitation

- Set up a new multi-agency countywide Youth Justice and Exploitation Service
- Established county wide missing and exploitation panels and networks
- Developed a Joint Panel between the police and youth justice service for children where there are both risks of offending and safeguarding concerns
- Regular training for staff in exploitation



Tackling Criminal Exploitation

Across Oxfordshire we now have

- Operational Multi-agency Risk Meetings chaired by senior police officer
- Use of police data-driven tools to identify young people at risk
- Extensive enforcement operations against county lines, connected to MPS and WMP



The Education System

- Tightened up all systems to ensure timely practice where children are not in education/not on a school roll including through a new multi-agency panel
- Plans in place to improve in year admissions processes to schools where children have been excluded from school or need to change schools



Working Together

- Developing whole system approaches to early help, managing the Front Door and safeguarding services closely linked to the new Youth Justice and Exploitation Service
- Working with the University of Bedfordshire to improve our contextual safeguarding offer



Climate Action Framework: Climate Active Council





Progress on delivery

Becoming a climate active council

- Climate action (CA) as cross-cutting theme of Corporate Plan
- Property and investment strategies

 Teviewed to support CA
 Commitments
- Climate impact assessment (CIAs) of 2021-22 budget proposals
- CIAs with committee reports for policy, service changes, projects or programmes
- Prioritisation tool for infrastructure schemes
- CA as key theme in service planning
- Staff-led climate action group

Operating at netzero carbon by 2030

- £2.1m Public Sector Decarbonisation Fund awarded for 7 corporate buildings and 4 schools
- Solar PV, battery storage and heat pump installed at Benson Library, now off gas grid
- 31.5% of street lights converted to LED
- Policy to be 'electric by default' 21 EVs and 44 EV charge points across 17 council sites
- Green grid electricity for corporate estate and maintained schools

Enabling a zero-carbon future for Oxfordshire

- Zero-carbon vision for Local Transport and Connectivity Plan under consultation
- £2.9m grant funding for Active Travel projects e.g., LTN, cycle routes
- Oxford and Bicester LCWIP approved
- Zero Emissions Zone pilot consultation completed
- Park n Charge rolling out charging in District car parks
- £1.5m Green Homes Grant awarded to improve energy efficiency in households in fuel poverty
- Carbon reduction pilot for infrastructure schemes
- Continued support of our flagship Community Action Group programme




Greenhouse gas report 2019/2020





What is included in the GHG report




GHG emissions 2019/20

19,164 tonnes CO₂e (12.1% reduction from 2018/19)






What is included our 'carbon neutral by 2030' target

Energy efficiency measures and carbon reduction projects 2019-20

- 2,827 street lighting lanterns replaced with LEDs
- New energy efficient boilers were installed
- A heating control project at Speedwell House
- 42 PV panels with a 12.81kWp were installed in Ron Groves House
- 34 EV charging Points installed across 17 buildings
- 16 Electric vehicles (EV) were added to the fleet bringing a total of EVs to 21
