Disclosable Pecuniary Interests

Declaration at meetings

A. What is a disclosable pecuniary interest (DPI)?

- 1. The interest must be:
 - Yours
 - Your spouse or civil partner's
 - Somebody's with whom you are living as a husband or wife, or as civil partners.
- 2. It must relate to business interests (for example employment, trade, profession, contracts, or any company with which you/spouse/partner are associated); or wider financial interests (trust funds, investments, sponsorship, assets, and interests in land or property).

B. When do I have to declare an interest at a meeting?

3. **Only** when an item on the agenda relates to a matter which affects your <u>pecuniary</u> interests or those of your spouse/partner.

C. What must I do?

4. If you are attending a meeting and the agenda involves consideration of an item in which you have a pecuniary interest then, unless you have a dispensation:

You must:

- Declare the fact of the interest and the nature of it
- Withdraw from the room when the meeting discusses and votes on the matter

You must not

- Participate in any discussion at the meeting
- Vote on the matter
