Questions from County Councillors

Councillor Howson put the following Question to Councillor Hibbert-Biles:

What steps are being taken by the County council to ensure no child is forced to attend any school both rated inadequate by Ofsted and in financial special measure to the Funding Agency?

I have that date in my diary as also the meeting of Schools Forum, does that affect this meeting mean the Cabinet Member won't be attending School Forum?

Councillor Hibbert-Biles answered as follows:

The Council seeks whenever possible to meet parental preferences expressed for school places and typically manages to meet 90%, or more, of first preferences. Sometimes it is not possible to meet any of a parent's preferences and in such a circumstance the Council will, in order to satisfy its duty to make a school place available to all who request one, identify the nearest school with an available place and offer this. Unfortunately, it is possible that this could be a school which is subject to a financial warning notice and also judged inadequate by Ofsted.

Parents are not obliged to accept the offer of the place at the school but they must ensure that their child receives an appropriate education. They could do this by requesting a place at a more distant school but this would not entitle them to free home to school transport if it is over the statutory walking distance.

With regards to attending the Delegated Decisions meeting, this is my intention and then travel to attend Schools Forum afterwards"

Councillor Howson asked the following supplementary question:

I recognise the excellent work in relation to Chiltern edge and other schools. However, I am particularly concerned about St. Gregory the Great which has now been in special measures for two years and future employees being put off.

Councillor Hibbert-Biles answered as follows:

St. Gregory the Great has been a difficult situation, made more difficult by the fact that it is run by the diocese from Birmingham. However, we have had a very productive meeting with the diocese and plans are in motion for change. I will keep you informed of any progress.
