DIRECTOR RESIGNATION

RECOMMENDATION

- 1. The Shareholder Committee is RECOMMENDED to
 - a) Note the resignation of Cllr Liz Leffman as a director of Oxfordshire Local Enterprise Partnership (OxLEP).

Executive Summary

2. At its meeting on 19 November the Cabinet established the Shareholder Committee to act as the sole member of the OxLEP company, providing strategic oversight and taking those decisions which are reserved to the sole member of the company by the Articles of Association. As the Leader will now be a member of the Shareholder Committee she has resigned as a director of OxLEP.

Background

- 3. In November 2024 Cabinet agreed to introduce new governance arrangements following the transfer of local enterprise partnership functions to the council on 1 April 2024. These changes include the establishment of the Shareholder Committee as a Committee of Cabinet to take decisions on any matters that are reserved to the Council as member in the company's Articles of Association and to receive annual and periodic reports for the company.
- 4. The Leader took no part in the vote at the Cabinet meeting on 19 November due to being a director of OxLEP. To avoid any conflicts of interest the Leader has written to the OxLEP Company Secretary to resign from her role as a Director. The Company Secretary has notified the council's democratic services team of the resignation.

- Working with local businesses and partners for environmental, economic and social benefit
