# CHIPPING NORTON: MARKET PLACE – PROPOSED MARKET TRADER PERMITS

### Report by Director of Environment and Highways

#### RECOMMENDATION

#### The Cabinet Member is RECOMMENDED to:

- a) Approve the introduction of 'No Waiting at Any Time' restrictions on sections of Market Place, and
- b) Approve a change to the current 2-hour restrictions on Market Place, to restrict parking on Wednesdays to Market Traders only (MT prefix), as advertised.

## **Executive Summary**

- The County Council have been approached by West Oxfordshire District Council (WODC) to promote a change to the existing restrictions on Market Place Chipping Norton, to restrict parking on Wednesdays to Market Trader Vehicles only.
- 2. A Market is held on Market Place each Wednesday which requires the area to be kept clear for stalls and market trader vehicles. Although signs are in place to warn motorists not to park on a Wednesday, these are regularly ignored which is causing problems for the operation of the market.
- 3. The proposals include the introduction of designated market trader permits, which will be administered by the district council, with details provided to our enforcement teams. A change to the traffic orders and signage will allow for more robust enforcement on market days, which will act as a deterrent for further infringements.
- 4. The report presents responses to the statutory consultation on the proposed parking controls as shown in **Annex 1**.

## **Sustainability Implications**

5. The proposals would help facilitate a safer environment for pedestrians and other users during the operation of the market and will encourage users to find alternative parking.

## **Financial Implications**

6. The proposals are being funded by the district council, so there are no implications for county council budgets.

### **Legal Implications**

- 7. The consultation that has been undertaken complies with the consultation requirements for the various elements as required by law including under the Highways Act 1980, the Road Traffic Regulation Act 1984 and any other relevant legislation.
- 8. The scheme has been promoted by Oxfordshire County Council as the Highway Authority and Traffic Authority under the Highways Act 1980, and the Road Traffic Regulation Act 1984.

# **Equalities and Inclusion Implications**

9. No negative impacts on equality or inclusion have been identified under the proposals.

#### **Formal Consultation**

- 10. Formal consultation was carried out between 19<sup>th</sup> June and 18<sup>th</sup> July 2025. A notice was published in the Oxford Times newspaper, and an email sent to statutory consultees & key-stakeholders, including Thames Valley Police, the Fire & Rescue Service, Ambulance service, Bus operators, countywide transport/access & disabled peoples user groups, Chipping Norton Town Council, West Oxfordshire District Council, the local District Councillors, and the County Councillor representing the Chipping Norton division.
- 11. A total of ten responses were received via the online survey during the course of the formal consultation, with eight in support and two objecting.

- 12. Thames Valley Police responded to confirm that they have no objection to the proposal.
- 13.A representative of West Oxford District Council has responded to confirm support for the proposals.
- 14. The full responses are shown in **Annex 2**, and copies of the original responses are available for inspection by County Councillors. Any comments received that Officers identify as containing personal abuse and/or other personal information will be redacted as appropriate.

### Officer Response to Objections/Concerns

- 15. The majority of respondents viewed the proposals as a positive change, sighting that the market should be allowed to operate without hinderance. Plus, the changes will make it clearer that there is no parking while the market is in operation.
- 16. The two objections received were on the grounds that users of the kebab van should be allowed to park on Market Place after midnight on a Tuesday. The other was on the grounds of disabled bay provision, which is not part of the proposals.
- 17. Officers feel that the proposals will make the restrictions clearer and allow effective enforcement of the restrictions to prohibit parking on market days.
- 18. For the small number of users for the kebab van in the early hours of Wednesday morning, there is alternative parking within the area which will be freely available at that time of day. Further relaxing the restrictions, may encourage vehicles to be left overnight which would undermine the purpose of the changes.

## **Monitoring & Evaluation**

19. It is suggested that the restrictions are kept under review and further changes are considered if deemed necessary by West Oxfordshire District Council who support the operation of the Markets.


